CALL FOR APPLICATION STUDENTS 2024-2025

We are pleased to inform students (LMD) that we have Two (**02**) Mobility Grants for studies under Erasmus+ KA171, which is pursued by the Inter-Institutional Agreement (IIA) between UNIVERSITE OF BISKRA and IZMIR INSTITUTE OF TECHNOLOGY (Türkiye). The nominated applicants will spend approximately five (05) months at the receiving institution during the second semester 2024-2025.

The program supports people with fewer opportunities to participate in the call for applications.

Eligibility

- ✓ The accepted domains according to the **Department names** in IZTECH (<https://en.iyte.edu.tr/>) as follows:
 - Department of Architecture,
 - Department of industrial design,
 - Department of conservation and restoration of cultural heritage (this Department only offers Masters and PhD programs)
 - Department of city and regional planning
- ✓ A student must have a CGPA (Cumulative Grade Point Average) of at least 10.50 out of 20 for undergraduate students and 11 out of 20 for graduate students to apply for Erasmus+ Mobility.
- ✓ The applicant should have at least B1 in English,
- ✓ Submit your candidature before the deadlines.

For the Bachelor and Master Students: Before your participation, FOR THE CREDIT TRANSFER, you must confirm with your Head of Department the modules that you will study there, in which he or she could recognize it after the mobility according to the modules taught here at our university.

Also, If you do not have Biskra University email, you have to email our colleague Sihem BENAOUNE siham.benaoune@univ-biskra.dz and enclose a copy of the enrollment certificate 2024-2025 to the email.

For the PhD Students: Check the doctorate offers opportunities before submission.



Evaluation of student applications are given below:

- **Academic achievement level** (50%, i.e. out of 50 points)
- **English language level** (50%, i.e. out of 50 points)
- Additional point for students with disabilities, or students who rely on state's social care/shelter support for a living or are disaster victims (provided that the disability/ state's social service support/disaster support is documented) (+10 points)
- Reduction of points for students who have previously benefited with or without a grant by previous Erasmus+ (2014-2020 or 2021-2027) within the same study cycle, from study or internship mobility within the scope of the same project type. (-10 points)
- Reduction of points for students who apply for the mobility in the country of citizenship (nationality of Turkish Republic) (-10 points)
- Reduction of points for students in case of failure to participate in the mobility despite being selected, without submitting a waiver notice in due time (-10 points)
- Reduction of points for students in case of unexcused non-attendance to the meetings/trainings organized in relation to (*if applicable in the institution*), in the subsequent applications to be made by the student

- **Files review date: December 13, 2024.**
- **The nomination list is due on December 20, 2024.**

Remark: Travel support is 275 Euro, while individual support is 800 Euro per month (after arriving at receiving institution). Mobility participants will have the 80% of their grant when they arrive the receiving institution, the remaining 20% will be awarded to those who successfully meet all the conditions of their mobility.

The shortlisted applicant will bear his/her own travel expenses.
